Children who are discharged to permanency must not re-enter foster care for the following 12 months to be counted in this measure.

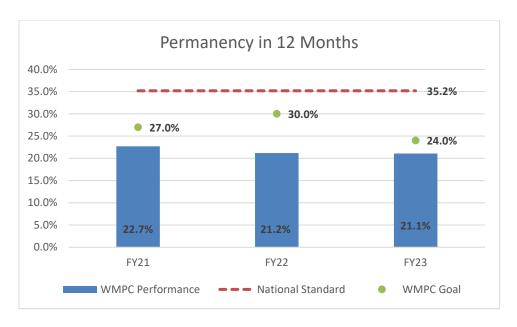
